Release Of Liability
And Assumption Of Risk Agreement

IN CONSIDERATION of being permitted to participate in any way in the sport and activities of Motocross under the auspices of RIMX LLC, Jordan Carlson, Richmond, RI. RIMX LLC, or Buttonwoods MX I acknowledge and agree that:

1. The risk of injury from the activity and equipment involved in motorized off road activities is significant including **THE POTENTIAL FOR PERMANENT DISABILITY AND DEATH**, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist;
2. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown **EVEN IF ARISING FROM THE NEGLIGENCE** of those persons released from liability below, **AND ASSUME ALL RESPONSIBILITY FOR MY PARTICIPATION**; and
3. I understand that the activities of motorized off road activities are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazards during my participation, I will bring such to the attention of the nearest official as soon as practical; and
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **FOREVER RELEASE AND HOLD HARMLESS RIMX LLC, Jordan Carlson**, Buttonwoods MX, THE OWNERS AND LESSORS OF THE PREMISES USED TO CONDUCT THE MOTORIZED OFF ROAD ACTIVITIES, THEIR OFFICERS, OFFICIALS, AGENTS, AND/OR EMPLOYEES ("releasees"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH**, or loss or damage to person or property, **WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, except that which is result of gross negligence and/or wanton misconduct.
5. I understand and agree that the release of Liability AGREEMENT covers each and every motorized off-road activity and/or event in which I participate or attend hereafter.
6. **ABSOLUTELY NO RIDING UNDER THE INFLUENCE** of drugs or alcohol for your safety and the safety of others.
7. I agree I have fully inspected track conditions and agree they are suitable and in satisfactory condition.
8. I understand that at any time if I am deemed to be riding or acting in an unsafe manner I will instantly lose my privilege to be on the property.
9. I acknowledge the risks associated with this sport and waive any and all right to collect compensatory or statutory damages from activity on said property.
10. I agree to cover all legal fees incurred by property owners from any claims I may bring forth regardless of outcome.
